I. BACKGROUND

Micro Enterprises Support Programme Trust (MESPT) is a Kenyan development organization that supports inclusive economic growth by strengthening enterprises, value chains, and market systems. To effectively implement its programs and support operational efficiency, MESPT intends to procure three (3) motor vehicles for official use.

MESPT hereby invites **Request for Quotation (RFQ)** from eligible, reputable, and experienced motor vehicle dealers and suppliers to participate in a shortlisting process. The shortlisted vendors will subsequently be invited to submit detailed bids through a competitive tendering process.

2. OBJECTIVE OF THE TENDER

The objective of this RFQ is to: - Identify and award competent vendor (s) capable of supplying used (not locally) motor vehicles that meet MESPT's specifications and quality standards.

The vehicles must already be locally available for immediate purchase.

3. SCOPE OF SUPPLY

The scope under this RFQ includes the supply of the following vehicles (brand Toyota):

1. **Two (2) Toyota Land Cruiser Prado**
2. **One (1) Toyota Rav4**

The vehicles are expected to be: - Used Ex-Japan (Not locally used) - Right-hand drive - Suitable for Kenyan terrain and operational conditions - Compliant with Kenyan regulatory and importation requirements.

- Model Year: 2017/2018 or latest
- Engine capacity: 2.7L or 3.0L
- Transmission: Manual/Automatic
- Fuel type: Petrol/Diesel
- Seating capacity: 5 or 7 seats
- Standard safety and comfort features
- Provide a datasheet for detailed specifications of each vehicle, including mileage and year of mfg

3.2 Toyota Rav4

- Model Year: 2017/2018 or latest
 - Engine capacity: 2.0L or 2.5L
 - Transmission: Manual/Automatic
 - Fuel type: Diesel or Petrol
 - Drive: AWD/2WD/4WD
 - Provide a datasheet for detailed specifications of each vehicle, including mileage and year of mfg.

- Details on stock availability and unit features
- Availability of a physical vehicle yard

4.3 Financial Capacity

- Quotation for the units vs overall features.
